ASYLUM in the time of COVID-19 & BREXIT

Mike Brown, CLEAR Project Manager spoke at the joint meeting with the Romsey Group in February

BACKGROUND INFORMATION

Almost 80 million people displaced across the world. 30 million refugees, half under 18; 4 million asylum seekers; and 46 million internally displaced people (IDPs).. Two-thirds of all refugees come from: Syria, Venezuela, Afghanistan, South Sudan and Myanmar.

Asylum seekers, are people waiting for decision on refugee status or the outcome of an appeal. They are not eligible for mainstream benefits, but have a subsistence of £37.75 per week and are provided with accommodation. They have full access to the NHS and free education for school-age children. They are not allowed to do any work.

Those with **Refugee status** are allowed to stay in the UK for 5 years, with family reunion rights. They are eligible for all mainstream benefits and full access to NHS care. They are permitted to work, and they must find their own accommodation. They will normally be granted permanent leave after 5 years.

Those **refused refugee status**, must leave the UK *without delay*. They are evicted from their accommodation within 21 days and are liable to arrest, detention & enforced removal. They have no recourse to public funds and no access to free secondary medical care. They are not allowed to live in rented accommodation, or to have a bank account or driving licence and they are not allowed to work.

Those who can't leave the UK immediately are entitled to access **Section 4 Support**. This entitles them to accommodation and £37.75/week. Not allowed cash but have an Aspen debit card which is topped up weekly.

EFFECTS of COVID-19

There has been a 30% drop in refugees reaching the EU. Even so there have been longer delays in determinations. The dispersal of refugees reaching UK has ben halted since March 2020. Move -on has also been suspended. New entrants have been accommodated in hotels. Detainees at risk of infection. Refugees have not had the equivalent of the Universal Credit uplift. Enforced removals have continued through this period.

ASYLUM & BREXIT

Whilst international obligations remain, there is no harmonisation with EU policy and there is no access to EU funding. The Dubs Amendment, which would have ensured that the UK continues to allow unaccompanied child refugees in Europe to reunite with family members here in the UK was voted down by this Government. Whilst part of the EU the British Govt had previously agreed to accept the Amendment. The Dublin 111 agreement, which is the mechanism for determining which member state is responsible for examining an asylum claim, no longer applies to the UK. The Home Office is now responsible for patrolling UK waters.

LIFE as an ASYLUM SEEKER

The following exemplify the life of an asylum seeker:

Loss, trauma/PTSD, culture shock, benefit dependency, language issues, harassment and insecurity/vulnerability.

SITUATION in SOUTHAMPTON

Southampton has 190 bed spaces for asylum seekers, made up of a mixture of single people and families. The accommodation is a mixture of HMOs and flats and houses. There is also hotel accommodation (74 places) for new arrivals. There is a mixture of families, fully refused asylum seekers and refugees seeking work.

TAKE ACTION

ASK YOUR MP TO DEFEND THE DEFENDERS

In recent years, human rights defenders around the world have faced increasing levels of repression. Those working on issues such as environmental, land, women's, LGBT+, indigenous and minority group rights are at heightened risk. The pandemic has made the situation worse.

The UK government has a vital role to play in supporting and protecting human rights defenders globally. It says that promoting human rights abroad is an essential part of its foreign policy, but does not have a comprehensive strategy to support and protect human rights defenders.

On 10th February, Amnesty International UK and the University of York published a report; "On the human rights frontline: How the UK government can defend the defenders".

What to do:

- Find the contact details for your MP at: members.parliament.uk/FindYourMP
- Write them a letter based on the points below. Personalise your letter as much as possible.

IN YOUR LETTER

- Explain that AI UK has just published "On the human rights frontline: How the UK Government can defend the defenders, which calls for a UK Government strategy to support and protect human rights defenders around the world.
- Urge them to write to Secretary of State for Foreign, Commonwealth and Development Affairs Dominic Rabb and ask him to commit to developing a cross-departmental gender responsive and adequately funded strategy.
- Emphasise that such a strategy would both help human rights defenders and maximise the UK Government's impact on a range of its foreign and development policy priorities.

FIRST SOUTHERN STATE TO ABOLISH THE DEATH PENALTY

Virginia's move toward abolition is a landmark event. Having been the first state to administer an execution in the USA, Virginia has a long history with the death penalty starting in 1608. Over the course of four centuries, the state has executed a total of 1,390 individuals. This marks Virginia as the state with the highest total number of executions in the United States.
