There was no speaker at the June meeting, below is a summary of a recent message from **Nabila KHAN**, **AIUK Country Coordinator for China and Taiwan**. (The original message was in the monthly mailing from Amnesty).

She starts by noting that since taking on the role of Country Coordinator for China and Taiwan in October 2020 the Human Rights issues in China had really intensified and sadly worsened. She highlights three areas in particular:

Firstly, the most prominent and ongoing issue has been the plight of the **Uyghur ethnic group** located in the Xinjiang Autonomous Region in China's North West. Currently, it is estimated that over 1 million Uyghurs have been sent to "re-education" camps, whilst other groups may term this a cultural genocide, Amnesty has found the burden of proof has not been met and have decided to term this as a crime against humanity.

Secondly, the **Belt and Road initiative (BRI).** The BRI is the signature foreign policy initiative of China and Xi Jin Ping (President of China). It aims to rework global trade routes in a way that is favourable to China, with the aim of increasing Chinese hegemony and making China the dominant superpower. There are two roads, the overland "belt' that goes from China (through Xinjiang) to Eurasia (through countries such as Pakistan and Kazakhstan) out towards Europe. There is also a maritime "road" that goes through maritime sea routes but is less significant in terms of foreign policy. The BRI is the main reason for the current situation in Xinjiang, as Xinjiang is key to the success of the BRI and holds tremendous geopolitical importance to China. Nabila Khan is of the opinion that the Chinese state is incredibly fearful of balkanization and separatism, hence the presence of an ethnic group who are not Han Chinese, do not speak Chinese and practise a different religion and culture is very threatening to the Chinese state. As such, the Chinese state has chosen the most extreme and frankly unnecessary way of keeping control over Xinjiang.

Thirdly the situation in **Hong Kong** which has been deteriorating rapidly. Last year the Chinese government introduced a National Security Law. This means the criminalisation of any act of:

- Secession-breaking away from the country
- Subversion-undermining the power or authority of the central government
- Terrorism-using violence or intimidation against people
- Collusion with foreign or external forces.

Last week the police arrested senior executives of the Apple Daily newspaper in Hong Kong, for breaking national security law.

Amnesty's International Secretariat based in Hong Kong has done a lot of work on the national security law. Khan is hoping to work with higher/further educational institutions to speak out against this law.

Khan is also working on getting the government of Pakistan to speak out against the human rights abuses of the Uyghurs. In an attempt to allow UN investigators into Xinjiang Autonomous Region to conduct their own independent investigation into the situation.

#### EREN KESKIN TURKEY

Leading lawyer given six-year jail term

In February, prominent human rights lawyer Eren Keskin was sentenced to six years in prison on the absurd charge of "membership of an armed terrorist organisation". She was convicted under Article 301 of the Penal Code, which makes "denigrating" the Turkish nation a criminal offence.

Eren, co-chair of the Human Rights Association, has dedicated her life to defending the rights of women, prisoners, and families of the "disappeared". She has been repeatedly prosecuted, and sometimes convicted, under articles of the Penal Code that curtail the right to freedom of expression. The volume of cases brought against Eren amounts to judicial harassment, and she has also been physically attacked and subjected to death threats.

Eren's case is part of the Ozgür Gündem trial, which concerns a daily newspaper that was closed in 2016. She currently remains at liberty pending her appeal. After being sentenced, Eren tweeted: "I have been prosecuted many times and jailed for my thoughts, I'm still here. I'm not going anywhere".

#### APPEAL

Urge the minister of justice to overturn Eren Keskin's conviction. Call for the outstanding cases brought against her for her role as editor-in-chief of Ozgür Gündem to be dropped. State that she must be allowed to exercise her right to freedom of expression and carry out her human rights work free from reprisals and judicial harassment.
